New Manufacturing Lines Mean Major Growth for Columbus Region Company

USG is purchasing seven new product lines from Sensus, a Xylem brand, and this expansion will allow them to control and maintain the product lines. Their operation will be serving many local, national and international clients with their products.

"The success of USG is a story about two extraordinary entrepreneurs making a meaningful difference," said Andrew J. Ginther, mayor of Columbus. "They're doing more than creating jobs; they're rapidly ascending within their industry while putting Columbus on the map as a leader of manufacturing in the 21st century."

The new USG facility will be located at 1050 Dearborn Drive in Columbus. The 120,000 square foot expansion will allow the company to grow from 17 jobs to 49. \$842,406 will be invested in the project to fund facility costs, training, and purchase of new equipment. Hiring will begin immediately.

"When veterans commit to getting positive results, they don't give up until they succeed, which has been a driver for Utility Solutions Group's success in Ohio," said J.P. Nauseef, JobsOhio president and CEO. "USG has demonstrated a keen ability to find a niche in the manufacturing market that is growing demand for this

expansion that will allow the company to more than double its Columbus workforce."
